Non Skier or Snowboarder	First time skiing/snowboarding. Individual has never skied or snowboarded before.
Beginner	The participant has skied or snowboarded once or twice of a few times per year and has experienced and maintained control on a number of novice hills of varying difficulty. Able to stop and turn both directions with some success. They are comfortable on green/beginner and some blue/intermediate slopes. May need assistance with getting on or off the lifts.
Intermediate	The participant has skied or snowboarded on many occasions and has experienced a variety of hills and different ski areas. Can turn and stop under control using recognized formal techniques. Can ski/ board with confidence on blue slopes and possibly some black/advanced slopes.
Advanced	The participant is an experienced and competent skier or snowboarder. He received formal instruction, knows and understands the Alpine Responsibility Code and can demonstrate ability at an advanced level. Can be called upon to assist supervisors.

ALPINE RESPONSIBILITY CODE:

The Ontario Snow Resorts Association has produced an Alpine/Cross Country Responsibility Code with the named ski area: **Batawa Ski Hill**, requires that you know and obey. Skiers/snowboarders must always ski/snowboard in control and be able to stop and change direction to avoid collisions with people or objects. **Batawa Ski Hill** May revoke a lift ticket for violation of the code or other unacceptable conduct.

I am aware that skiing and snowboarding involve many risks, dangers and hazards including, but not limited to: boarding, riding and disembarking chair lifts, carpet lifts and tows; changing weather conditions; avalanches; exposed rock, earth, ice, and other natural objects; trees, tree wells, tree stumps and forest deadfall; the condition of snow or ice on or beneath the surface; variations in the terrain which may create blind spots or areas of reduced visibility; variations in the surface or sub-surface, including changes due to man-made or artificial snow; variable and difficult conditions; streams, creek, and exposed holes in the snow pack above streams or creeks; cliffs; snow-cat roads, road-banks or cut-banks; collision with lift towers, fences, snow making equipment, snow grooming equipment, snow-cats, snowmobiles or other vehicles, equipment or structures; collision or impact with natural or man-made objects or with other persons; loss of balance or control; slips, trips and falls; accidents during snowschool lessons; failure to act sagely or within one's own ability or to stay within designated areas; negligence of other skiers, snowboarders and other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PORTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE. I am also aware that the risks, dangers and hazards referred to above exist throughout the ski area and that many hazards are unmarked.
